

## Liverpool, Walton Parliamentary Constituency

This is the first bulletin of 2013 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of housing supply and the economy and welfare reforms in the constituency.

### Housing Supply and the Economy



In the final quarter of 2012, there were 90 new dwelling starts and 70 dwelling completions in Liverpool LA area. Twenty starts and 10 completions were in the social sector. Dwelling starts have fallen from 230 in the previous quarter but fallen from 130 in the corresponding quarter in 2011.



Research by Northern Housing Consortium and Sheffield Hallam University into the contribution housing makes to the [economy in the north](#) shows that £10.3bn worth of output expenditure was made in the North in 2011/12. It is estimated that Liverpool Housing Trust supported £109.633 million worth of expenditure and supported 1,048 FTE jobs in the North West.



Recently released figures show that there are a total of 5,124 unemployed in the constituency (8.4% of the working aged population). This represents a 4.4% decrease on the same point in 2012. Some 11.1% of working-aged males and 5.8% of their female counterparts were claiming unemployment benefits in March 2013 and while male figures fell by 9.2% on the previous year, figures for females did so by 6.4% in the same period.

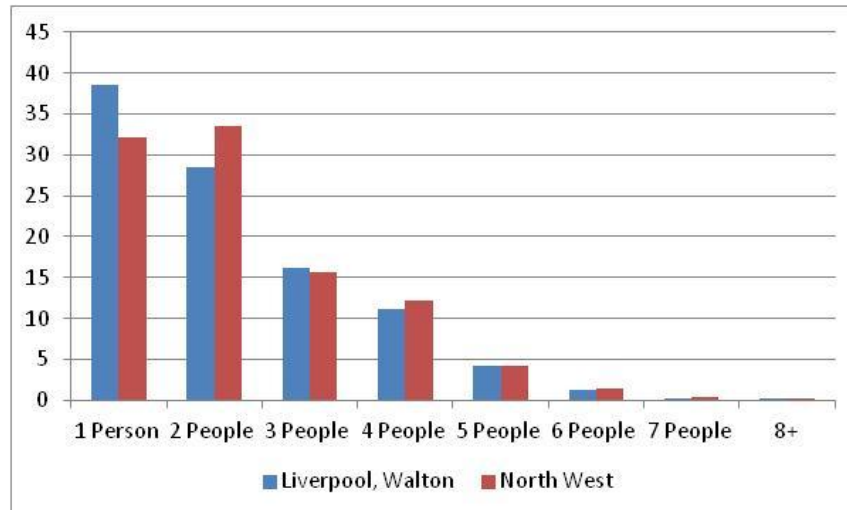


Figure 1: People per household

ONS data shows a higher proportion of smaller households with almost two-thirds of households (66.9%) having either one or two people living in them. Three-person households make up 11.1% of households. Figure 1 below shows the proportions of all households in the constituency and how this compares with regional figures.

## Welfare



The 2011 Census reports that 12,544 households (68.3%) now under-occupy their home in the constituency. A study by Sheffield Hallam University reported in the [Financial Times](#) shows that 11,200 households in Liverpool LA area will be affected by the 'bedroom tax' with an estimated £8.2m loss per year.



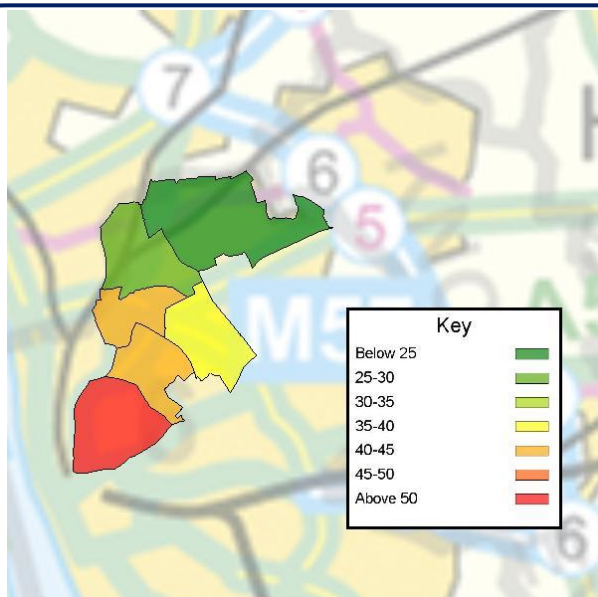
In last year's first edition of the constituency profiles we reported that 15,200 households receiving Housing Benefit in the constituency. In November 2012, there were 15,718 such claimants. This is 38.3% of all households in the constituency and a 3.4% increase on the 15,200 reported last year.



Annual Survey of Hours and Earnings (ASHE) for 2012 shows that in Liverpool, Walton, the median weekly pay is £306.80. This represents a decrease of 0.1% on the previous year. However, while full-time pay has fallen by 0.5%, part-time pay has increased by 27.1%.



Furthermore, Campaign to End Child Poverty 2012 data shows that in Liverpool, Walton, 7,922 children live in poverty – 37% of the child population in the constituency. Map 1 shows child poverty by ward and that the worst affected ward is Everton (53%).
