

Don Valley Parliamentary Constituency

This is the first bulletin of 2013 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of housing supply and the economy and welfare reforms in the constituency.

Housing Supply and the Economy



In the final quarter of 2012, there were 140 new dwelling starts and 140 dwelling completions in Doncaster. Ten starts were in the social sector and all completions were private. Dwelling starts have risen from 10 in the previous quarter but fallen from 100 in the corresponding quarter in 2011.



Research by Northern Housing Consortium and Sheffield Hallam University into the contribution housing makes to the [economy in the north](#) shows that £10.3bn worth of output expenditure was made in the North in 2011/12. It is estimated that St Ledger Homes supported £123.065 million worth of expenditure and supported 1,560 FTE jobs in Yorkshire and Humberside.



Recently released figures show that there are a total of 2,761 unemployed in the constituency (4.6% of the working aged population). This represents a 7% reduction on the same point in 2012. Some 5.9% of working-aged males and 3.1% of their female counterparts were claiming unemployment benefits in March 2013 and while male figures fell by 9.9% on the previous year, figures for females fell by 0.9% in the same period.

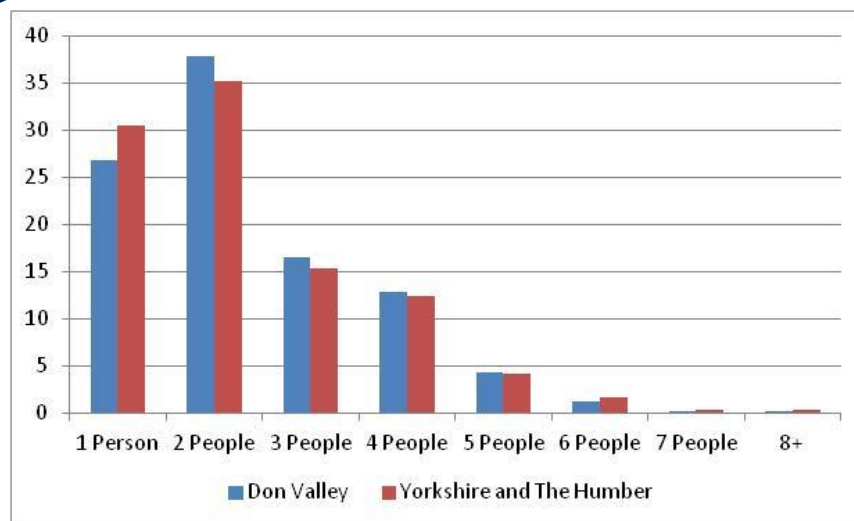


Figure 1: People per household

ONS data shows a higher proportion of smaller households with almost two-thirds of households (64.7%) having either one or two people living in them. Three-person households make up 16.5% of households. Figure 1 below shows the proportions of all households in the constituency and how this compares with regional figures.

Welfare



The 2011 Census reports that 32,193 households (79.3%) now under-occupy their home in the constituency. A study by Sheffield Hallam University reported in the [Financial Times](#) shows that 4,500 households in Doncaster LA area will be affected by the 'bedroom tax' with an estimated £3.1 m loss per year.



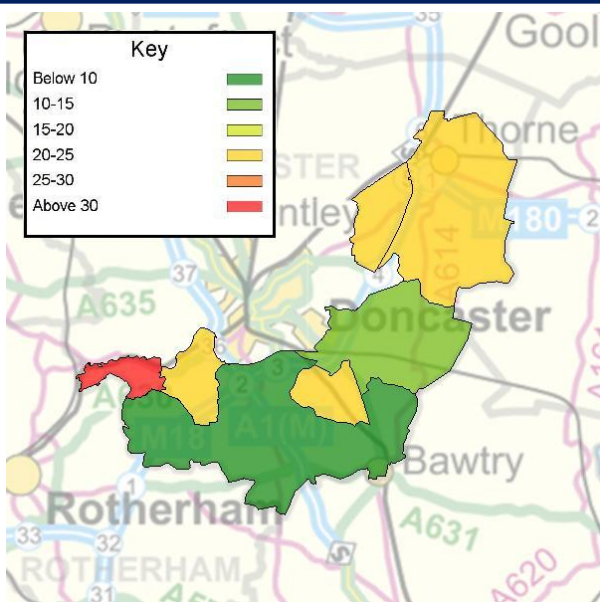
In last year's first edition of the constituency profiles we reported that 6,910 households receiving Housing Benefit in the constituency. In November 2012, there were 7,165 such claimants. This is 17.6% of all households in the constituency and a 3.7% increase on the 6,910 reported last year.



Annual Survey of Hours and Earnings (ASHE) for 2012 shows that in Don Valley, the median weekly pay is £360.80. This represents an increase of 2.5% on the previous year. While full-time pay fell by 3.9%, part-time pay has increased by 9.8%.



Notwithstanding this overall increase, Campaign to End Child Poverty 2012 data shows that in Don Valley, 4,149 children live in poverty – 20% of the child population in the constituency. Map 1 shows child poverty by ward and that the worst affected ward is Conisbrough and Denaby (31%).
