

## Skipton and Ripon Parliamentary Constituency

This is the first bulletin of 2013 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of housing supply and the economy and welfare reforms in the constituency.

### Housing Supply and the Economy



In the final quarter of 2012, there were no new dwelling starts and 20 dwelling completions in Craven LA area. All of these were in the private sector. Dwelling starts have fallen from 10 in the corresponding quarter in 2011. In Harrogate, there were 60 starts and 10 completions and dwelling starts have increased over the last year.



Research by Northern Housing Consortium and Sheffield Hallam University into the contribution housing makes to the [economy in the north](#) shows that between local authorities, ALMOs and registered housing providers, £10.3bn worth of output expenditure was made in the North in 2011/12, supported 116,000 jobs and 8,400 new homes were built in the previous year.



Recently released figures show that there are a total of 906 unemployed in the constituency (1.5% of the working aged population). This represents a 28.4% decrease on the same point in 2012. Some 2% of working-aged males and 1% of their female counterparts were claiming unemployment benefits in March 2013 and while male figures fell by 27.9% on the previous year, figures for females did so by 29.4% in the same period.

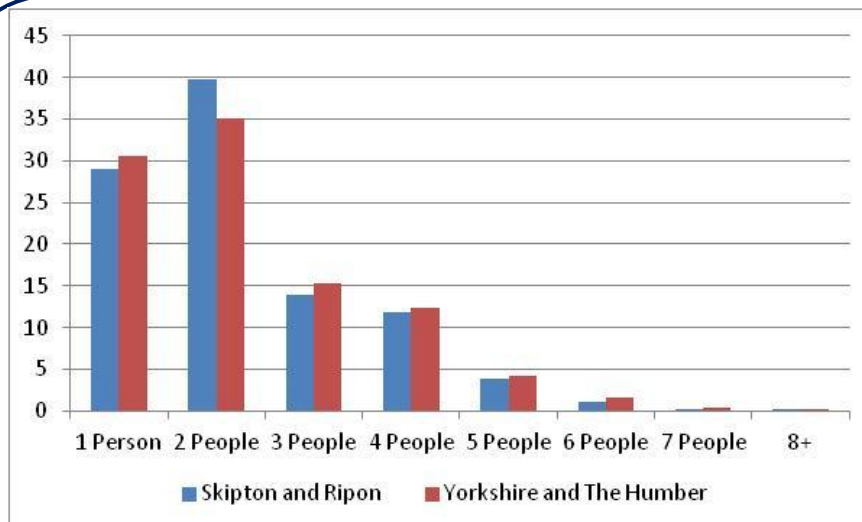


Figure 1: People per household

ONS data shows a higher proportion of smaller households with almost two-thirds of households (68.8%) having either one or two people living in them. Three-person households make up 14% of households. Figure 1 below shows the proportions of all households in the constituency and how this compares with regional figures.

## Welfare



The 2011 Census reports that 34,383 households (80.4%) now under-occupy their home in the constituency. A study by Sheffield Hallam University reported in the [Financial Times](#) shows that 400 households in Craven LA area will be affected by the 'bedroom tax' with an estimated £0.3m loss per year. Figures for Harrogate are 1,200 households with a £0.8m loss.



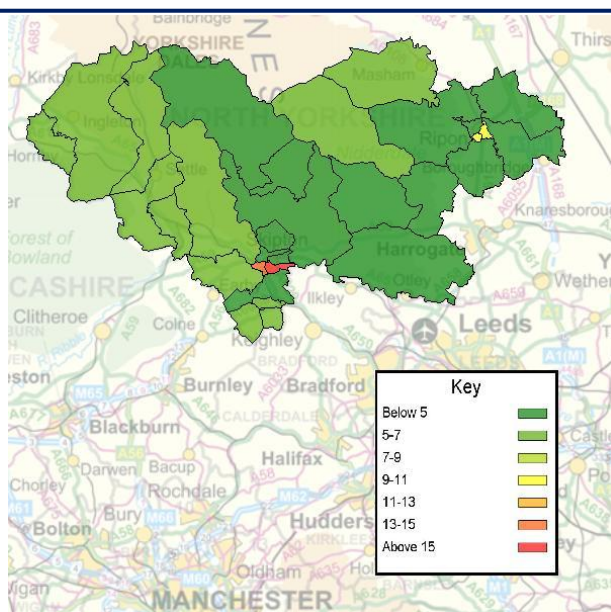
In last year's first edition of the constituency profiles we reported that 4,250 households receiving Housing Benefit in the constituency. In November 2012, there were 4,450 such claimants. This is 10.4% of all households in the constituency and a 4.7% increase on the 4,250 reported last year.



Annual Survey of Hours and Earnings (ASHE) for 2012 shows that in Skipton and Ripon, the median weekly pay is £376.20. This represents an increase of 9.1% on the previous year. While full-time pay has decreased by 1.7% over the last twelve months, part-time pay has risen by 6%.



Notwithstanding this overall increase, Campaign to End Child Poverty 2012 data shows that in Skipton and Ripon, 1,134 children live in poverty – 6% of the child population in the constituency. Map 1 shows child poverty by ward and that the worst affected ward is Skipton South (22%).
