

Thirsk and Malton Parliamentary Constituency

This is the second bulletin of 2013 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

Welfare Reform



[Real Life Reform](#) report is the result of a partnership between Northern Housing Consortium, seven registered providers and York University. Some findings emerging from the first report are that 65% of households have less than £10 per week to live on following rent and essentials such as food and bills. 83% of households are in debt (average £2,418). Households are reporting increased levels of stress and depression.



The Trussell Trust's latest figures show that more people are being referred to foodbanks with Benefit related problems since April's welfare reforms. Between April and June, over 150,000 people received three days' emergency food from a Trussell Trust foodbank - 200% more than the same period in 2012. The nearest foodbank to the constituency is in York.



The number of Housing Benefit claimants in the social sector has fallen in the constituency since the implementation of the under-occupation penalty. Such claims fell by 1% between March and May this year. Meanwhile, claims of Local Housing Allowance in the private sector fell by 2.1% in the same period compared with a North Yorkshire average decrease of 0.3%.




Figure 1: Change in weekly LHA costs

While the average Housing Benefit award grew by 0.3%, the average weekly LHA award grew by 0.2% but by multiplying the number of claimants by average weekly award an overall weekly LHA cost decrease of 1.9% (£1,840) can be estimated. Figure 1 shows how average costs have changed over this period by dwelling size.

Housing Market



Ministry of Justice data shows that in the Ryedale LA area, both social landlord possession claims and possessions in the first two quarters of 2013 have risen (as have private possessions) compared to the corresponding timeframe in 2012. Private claims have fallen by 25%. Meanwhile in Hambleton social landlord claims, possessions and private claims have fallen, while private possessions have remained steady at 3.




According to ONS figures, the population in the constituency fell by 1.2% from 98,437 in 2010 to 97,261 in 2011. The map below shows the population change by lower super output area and that the greatest population increase has taken place in the LSOA covered by the Thirsk ward (11.6%) and parts of Dales ward have seen greatest decrease (-13.5%) (note: data is not available for some LSOAs in 2011).



CORE data shows that social housing lettings have risen in the Ryedale LA area from 330 in 2011/12 to 356 in 2012/13 – an increase of 7.9%. In Hambleton, lettings fell by 7% to 425. This compares to an overall decrease of 8.1% in North Yorkshire.



In the year ending in March 2013, there were 621 decisions made by the planning authority in Ryedale. Some 77 of these (12.4%) were regarding developments for housing. The 98 housing related planning decision in Hambleton constitutes 9.9% of all the authority's decision. These figures represent 8.1% and 10.3% of all housing-related decisions in North Yorkshire respectively.
