

## Dewsbury Parliamentary Constituency

### Welfare Reform



The third [Real Life Reform](#) report found an increase in the average debt of respondents taking part in the study (£3,503) with debt repayments increasing by 58% since October. 46% of participants report having nothing left each week to live on once rent and essentials such as food and bills have been paid.



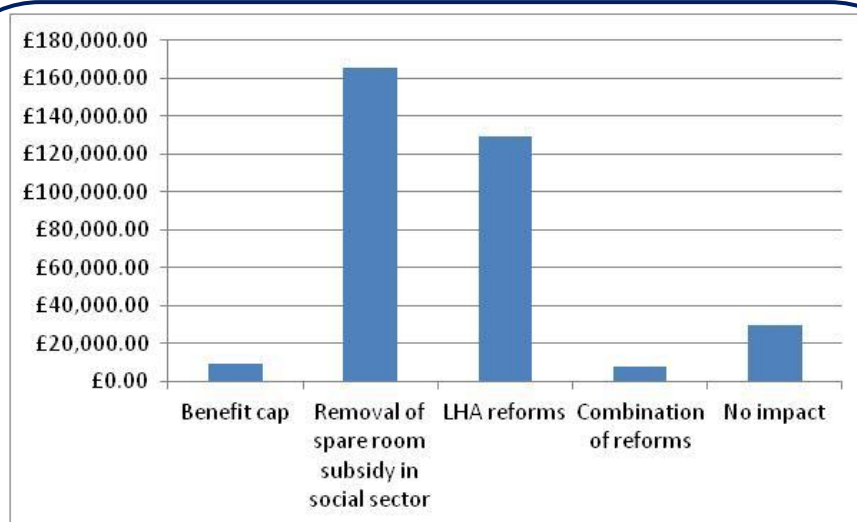
Last year we reported that in Dewsbury, 5,034 children live in poverty – 19% of the child population in the constituency. According to figures by The Children's Society, 2,423 children in poverty are estimated to miss out on the [warm home discount](#) in the constituency.



A number of sources report that households affected by the spare room subsidy cannot move due to a lack of suitable accommodation. In the first three quarters of 2013/14, there were 794 general needs lettings in Kirklees (CORE data). This compares to 1,224 lettings in the same period of 2012/13 (a 35.1% decrease).



Data released by the Department of Communities and Local Government in October shows that a total of £852,960 was allocated to Kirklees Council in Discretionary Housing Payment funding. Of that, £341,912 has been committed (40.2%). The greatest demand on this (£165,603) was allocated to support 492 households affected by the removal of spare room subsidy in the social rented sector.

## Housing Market



The Chancellor announced in his Budget Statement that the Help to Buy Equity Loan scheme will be extended until March 2020. Since its launch on 1<sup>st</sup> April 2013 to the end of February 2014, a total of 51 homes were bought in Kirklees with support of the scheme. This represents 7% of the 726 completed equity loans in West Yorkshire.



Average house prices in Kirklees in February 2014 stood at £109,515 an increase of 6.9% on the same period in 2013. This is being driven by sales volumes being on a general upward trend, ending on 445 in December 2013 compared with 399 in December 2012.



Vacant dwellings have been on a general downward trend since 2008. In October 2013 there were a total of 6,578 vacant dwellings in Kirklees compared with 7,922 in 2008. Of the 2013 figure, 41 were owned by housing associations. Long-term vacants have fallen by 34.5% since 2008.



In 2012/13, Kirklees Council made a total of 646 homeless decisions. Of these, 401 applicants were accepted as being homeless and in priority need (62.1%). The number accepted as being homeless equates to 2.32 per 1,000 households in the borough – up from 1.9 in 2011/12 and down from 2.04 in 2010/11.
