

## **East Yorkshire Parliamentary Constituency**

This is the first bulletin of 2014 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

## **Welfare Reform**



The third <u>Real Life Reform</u> report found an increase in the average debt of respondents taking part in the study (£3,503) with debt repayments increasing by 58% since October. 46% of participants report having nothing left each week to live on once rent and essentials such as food and bills have been paid.




Last year we reported that in East Yorkshire, 2,883 children live in poverty – 15% of the child population in the constituency. According to figures by The Children's Society, 1,387 children in poverty are estimated to miss out on the <u>warm home discount</u> in the constituency.



A number of sources report that households affected by the spare room subsidy cannot move due to a lack of suitable accommodation. In the first three quarters of 2013/14, there were 497 general needs lettings in East Riding of Yorkshire (CORE data). This compares to 611 lettings in the same period of 2012/13 (a 18.7% decrease).



Data released by the Department of Communities and Local Government in October shows that a total of £374,414 was allocated to East Riding of Yorkshire Council in Discretionary Housing Payment funding. Of that, £71,130 has been committed (19%). The greatest demand on this (£33,043) was allocated to support 110 households with 'no impact' awards.



## **Housing Market**



The Chancellor announced in his Budget Statement that the Help to Buy Equity Loan scheme will be extended until March 2020. Since its launch on 1<sup>st</sup> April 2013 to the end of February 2014, a total of 64 homes were bought in East Riding of Yorkshire with support of the scheme. This represents 16.4% of the 390 completed equity loans in the Humberside.




Average house prices in East Riding of Yorkshire in February 2014 stood at £134,759 an increase of 7.1% on the same period in 2013. This is being driven by sales volumes being on a general upward trend, ending on 463 in December 2013 compared with 362 in December 2012.



Vacant dwellings have been on a general downward trend since 2008. In October 2013 there were a total of 5,183 vacant dwellings in East Riding of Yorkshire compared with 5,906 in 2008. Of the 2013 figure, 10 were owned by housing associations. Long-term vacants have fallen by 28.3% since 2008.



In 2012/13, East Riding of Yorkshire Council made a total of 843 homeless decisions. Of these, 359 applicants were accepted as being homeless and in priority need (42.6%). The number accepted as being homeless equates to 2.36 per 1,000 households in the borough – down from 3.24 in 2011/12 and 3.26 in 2010/11.
