

## **Chorley Parliamentary Constituency**

This is the second bulletin of 2015 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

## **Financial Distress**



ONS figures show that in the year ending in June 2015, there were 51,000 people aged over 16 years old in employment (78.5%) in Chorley. There are 43,000 jobs in the constituency which equates to 0.69 jobs per 16-64 year old compared to 0.77 across the North West.



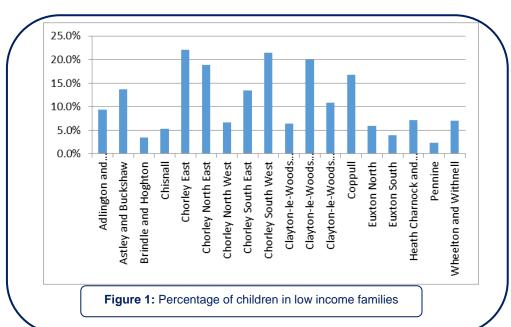
Experimental Jobseekers Allowance and out of work Universal Credit statistics produced by Jobcentre Plus shows that there were 985 such claimants in November 2015 (1.6% of 16-64 year olds), which is a 0.2% increase the previous year. This compares to 2.4% of people in the region (a 0.1% increase).



The latest Government data shows that there were 20,510 children in low income families in the constituency in August 2013 (12.9% of all children). Over four-fifths were in families in receipt of Income Support or Jobseekers Allowance while 13%, in families in receipt of Council Tax Credit and with less than 60% of median income.



Chorley East ward (22.1%) had the greatest concentration of such children followed by Chorley South West (21.4%). Chorley South West also has a higher than average proportion of children living in a family in receipt of Income Support or JSA (87.8%).



## **Housing Market**



In 2014/15, there were less than 5 homeless acceptances by Chorley Council. A total of 12 households were found temporary accommodation and there were no households that were not found accommodation at the end of March 2015 despite a duty being owed.



In October 2014, the total number of vacant homes was 1,485. This is a 2.4% decrease from 1,522 in 2009 compared with the 7.9% decrease in Lancashire. Long-term vacants fell by 16.8% over the same period. There was a total of 37 social vacants and 12 were classed as long-term vacant (32.4%).

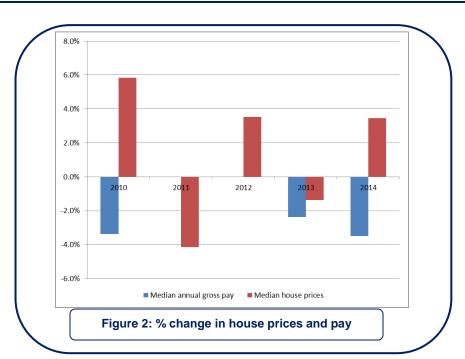


As at April 2014, there were 1,115 households on the housing waiting list in Chorley. This is a 26.8% decrease on the previous year 2,265. Furthermore, this figure represented a fall on previous years and the long-term trend is an 8.4% decrease on 2009 figures.

There are some clear signs of a recovery in the housing market with an increase in sales between 2009 and 2014 (59.9%) with greatest increase in sales of detached properties (ONS). The data also shows median house prices were highest in 2014 (£150,000).



As figure 2 shows, median house prices and pay have not grown at the same rate. Median house prices grew while median gross pay fell (ASHE) in 2014. As a result, the affordability ratio grew to 7.4 from 6.9 between 2013 and 2014.
