

Leigh Parliamentary Constituency

This is the second bulletin of 2015 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

ONS figures show that in the year ending in June 2015, there were 57,000 people aged over 16 years old in employment (77%) in Leigh. There are 36,000 jobs in the constituency which equates to 0.55 jobs per 16-64 year old compared to 0.77 across the North West.



Experimental Jobseekers Allowance and out of work Universal Credit statistics produced by Jobcentre Plus shows that there were 1,720 such claimants in November 2015 (2.6% of 16-64 year olds), which is a 0.4% increase on the previous year. This compares to 2.4% of people in the region (a 0.1% increase).



The latest Government data shows that there were 22,470 children in low income families in the constituency in August 2013 (18.2% of all children). Three-quarters were in families in receipt of Income Support or Jobseekers Allowance while 13.8%, in families in receipt of Council Tax Credit and with less than 60% of median income.



Leigh West ward (30.7%) had the greatest concentration of such children followed by Leigh East (19.7%). Leigh South has a higher than average proportion of children living in a family in receipt of Income Support or JSA (88.5%).

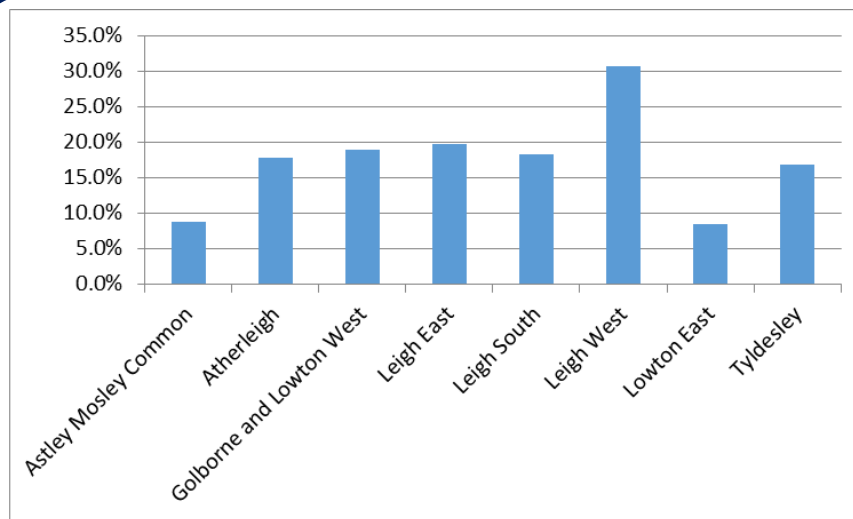


Figure 1: Percentage of children in low income families

Housing Market



In 2014/15, there were 175 homeless acceptances by Wigan Council. This is a 46.2% decrease on the 325 acceptances in 2009/10. Of these, 19 households were found temporary accommodation and there were no households that were not found accommodation at the end of March 2015 despite a duty being owed.



In October 2014, the total number of vacant homes was 4,520. This is a 17.9% fall from 5,504 in 2009 compared with the 37.5% fall in Greater Manchester. Long-term vacants fell by more than half (33.7%) over the same period. There was a total of 347 social vacants but only 24 were classed as long-term vacant (6.9%) which is a fall from 36 in the previous year.



As at April 2014, there were 2,912 households on the housing waiting list in Wigan. This is a 14.8% decrease on the previous year of 3,418. Furthermore, this figure represented a large fall on previous years and the long-term trend is a 36.2% decrease on 2009 figures.



There are clear signs of a recovery in housing market with year-on-year increases in sales between 2009 and 2014 (41.7%) with greatest sales of detached properties (ONS). The data also shows house price increase at their highest level since 2007 (£112,500).



As figure 2 shows, median house prices and pay have not grown at the same rate. Median house price growth outstripped that of median gross pay in 2014 (ASHE). As a result, the affordability ratio increased to 5.2 from 5.1 between 2012 and 2014.
