

# Bradford West Parliamentary Constituency

This is the first bulletin of 2015 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

## Financial Distress



Census data shows that in Bradford West, 62.3% of working aged people were working full-time and 37.7% worked part-time. The corresponding figures for the region are 69.3% and 30.7%.



The Annual Survey of Salaries and Hours (ASHE) shows that in the constituency (as a place of work), 20% of all employee jobs paid below the Living Wage in 2014 (£7.65ph), a decrease from 20.8% in 2013. This compares to 24.3% regionally and 21.7% nationally.

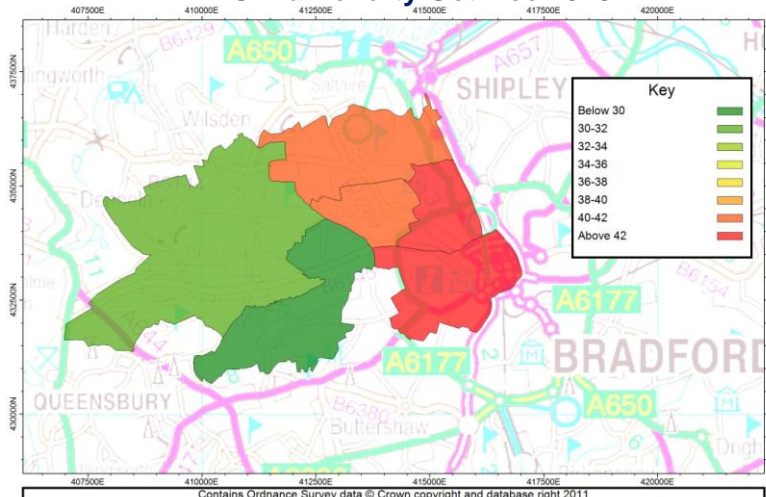


In the constituency, between September 2013 and September 2014, total Benefit sanctions fell by 20.6%. Employment and Support Allowance sanctions grew from none to 8. Meanwhile, Job Seekers Allowance sanctions fell from 422 to 327 (-22.5%) the period.



In a previous edition of the Constituency Profiles, we reported that in Bradford West, 28% of children live in poverty. One year on, we can report that figure, before housing costs, stands at 26.3%. However, when housing costs are taken into account, 39.4% of children live in poverty (End Child Poverty) and the map below shows that Manningham (44.9%) is the worst affected ward.

## Housing Market



After a general downward trend between Q1 2013 to Q2 2014, social landlord possession claims grew by 10.2% between Q2 2014 and Q4 2014 in Bradford (from 127 to 140). Over the same period, actual possessions grew by 22.9% to 43. Meanwhile, mortgage claims and possessions fell over the same period.



In the final quarter of 2014, Bradford Council made 177 homelessness decisions and accepted 65 households as being homeless and in priority need (36.7%). At the end of 2014, 53 households were housed in temporary accommodation, a 1.8% increase on the quarter ending in June.



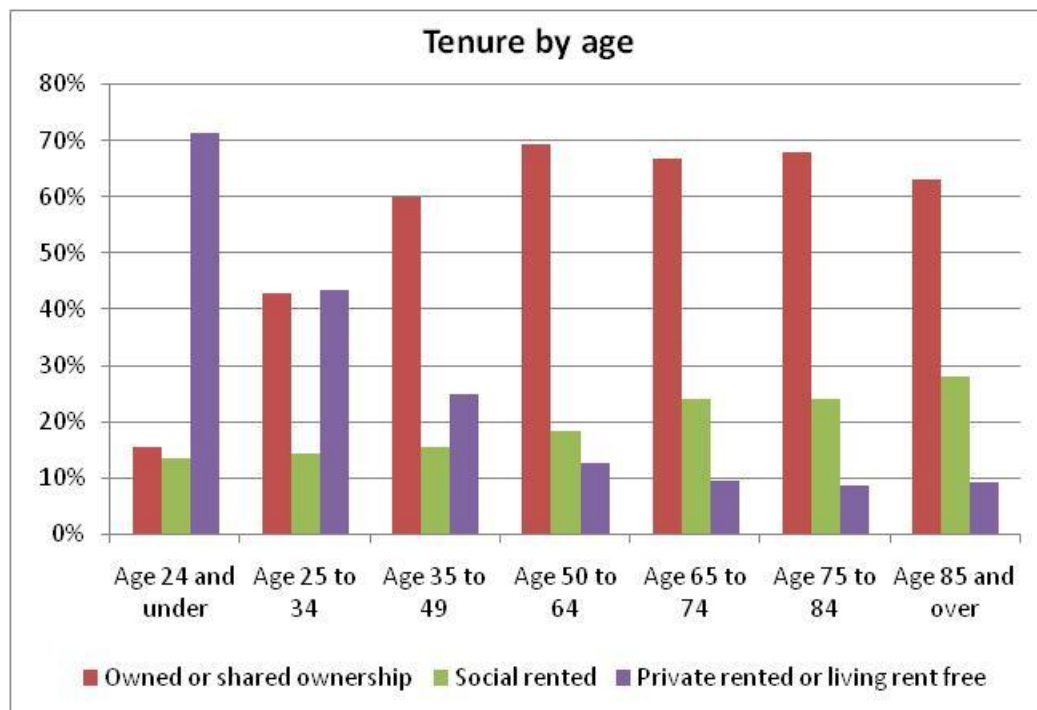
Some have pointed to a lack of new affordable homes being built as a reason behind the increase in homelessness. The latest annual figures show that in Bradford, while the number of new homes started and completions has increased (2012/13 to 2013/14), the proportion of social sector dwelling starts and completions have fallen.



Looking at quarterly building statistics, in the final quarter of 2014, there were 140 dwellings started and 150 completed in Bradford. Over one-fifth (21.5%) of starts but no completions were in the social sector. In the corresponding quarter of 2013, 18.8% of starts and 10.5% of completions were in the social sector.



Nomis data (2011) shows that in the constituency, 57% are owner-occupiers, 17% rent from a social landlord and 26% are private renters. However, looking at tenure by the age of the household reference person shows changes by age. There is a steep increase in owner-occupation between the ages of 24 and under (15%) and 50 to 64 year age bracket (69%) before falling to 63% for those aged 85 and over. Conversely, renting is more popular for those aged 24 and below (85%) before falling and then increasing slightly in later years.
