## **Financial Distress**

Above average



Census data shows that in Rotherham, 68.2% of working aged people were working full-time and 31.8% worked part-time. The corresponding figures for the region are 69.3% and 30.7%.




The Annual Survey of Salaries and Hours (ASHE) shows that in the constituency (as a place of work), 22.9% of all employee jobs paid below the Living Wage in 2014 (£7.65ph), an increase from 22.4% in 2013. This compares to 24.3% regionally and 21.7% nationally.



In the constituency, between September 2013 and September 2014, total Benefit sanctions fell by 51.5%. Employment and Support Allowance sanctions decreased from 12 to 6 (-50%) this period. Meanwhile, Job Seekers Allowance sanctions fell from 353 to 171 (-51.6%).



In a previous edition of the Constituency Profiles, we reported that in Rotherham, 26% of children live in poverty. One year on, we can report that figure, before housing costs, stands at 21.4%. However, when housing costs are taken into account, 33.3% of children live in poverty (End Child Poverty) and the map below shows that Rotherham East (45.1%) is the worst affected ward.

## **Housing Market**



After a remaining fairly level between Q1 2013 to Q2 2014, social landlord possession claims fell by 49.2% between Q2 2014 and Q4 2014 in Rotherham LA (from 128 to 65). Over the same period, actual possessions fell by 4.4% to 43. Meanwhile, mortgage claims and possessions fell over the same period.



In the final quarter of 2014, Rotherham Council made 67 homelessness decisions and accepted 13 households as being homeless and in priority need (19.4%). At the end of 2014, 29 households were housed in temporary accommodation, a 3.6% increase on the quarter ending in June.




<u>Some</u> have pointed to a lack of new affordable homes being built as a reason behind the increase in homelessness. The latest annual figures show that in Rotherham LS, while the number of new homes started has increased and those completed decreased (2012/13 to 2013/14), the proportion of social sector dwellings starts and completions have both fallen.



Looking at quarterly building statistics, in the final quarter of 2014, there were 110 dwellings started and 190 completed in Rotherham LA. Some 9.1% of starts and 10.5% of completions were in the social sector. In the corresponding quarter of 2013, no dwellings started but 11.8% of completions were in the social sector.



Nomis data (2011) shows that in the constituency, 56% are owner-occupiers, 29% rent from a social landlord and 14% are private renters. However, looking at tenure by the age of the household reference person shows changes by age. There is a steep increase in owner-occupation between the ages of 24 and under (15%) and 50 to 64 year age bracket (66%) before falling to 42% for those aged 85 and over. Conversely, renting is more popular for those aged 24 and below (85%) before falling and then increasing slightly in later years.
