

Scunthorpe Parliamentary Constituency

This is the second bulletin of 2015 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

Financial Distress



ONS figures show that in the year ending in June 2015, there were 41,000 people aged over 16 years old in employment (73%) in Scunthorpe. There are 45,000 jobs in the constituency which equates to 0.80 jobs per 16-64 year old compared to 0.74 across Yorkshire and the Humber.




Experimental Jobseekers Allowance and out of work Universal Credit statistics produced by Jobcentre Plus shows that there were 1,520 such claimants in November 2015 (2.7% of 16-64 year olds), which is a 0.5% fall on the previous year. This compares to 2.2% of people in the region (a 0.5% decrease).



The latest Government data shows that there were 20,340 children in low income families in the constituency in August 2013 (21.6% of all children). Over four-fifths were in families in receipt of Income Support or Jobseekers Allowance while 14.4%, in families in receipt of Council Tax Credit and with less than 60% of median income.



Brumby ward (33.4%) had the greatest concentration of such children followed by Frodingham (27.4%). Brumby also has a higher than average proportion of children living in a family in receipt of Income Support or JSA (86.1%).



Housing Market



In 2014/15, there were 104 homeless acceptances by North Lincolnshire Council. This is a 33.8% decrease on the 157 acceptances in 2009/10. Of these, 11 households were found temporary accommodation and there were 25 cases of a duty being owed but no accommodation found.



In October 2014, the total number of vacant homes was 3,072. This is a 4.9% decrease from 2,926 in 2009 compared with the 9.7% decrease in Humberside. Long-term vacants grew by 5.1% over the same period. There was a total of 350 social housing vacants and 53 were classed as long-term vacant (15.1%) which is an increase from 14 in the previous year.




As at April 2014, there were 9,902 households on the housing waiting list in North Lincolnshire. This is a 33.7% increase on the previous year of 7,408. Furthermore, this figure represented a large growth on previous years and the long-term trend is a 162.7% increase on 2009 figures.



There are clear signs of a recovery in the housing market in the constituency with an overall increase in sales between 2009 and 2014 (45.2%) with greatest increase in sales of detached properties (ONS). The data also shows median house prices being at their highest level since 2008 (£112,000).



As figure 2 shows, median house prices and pay have not grown at the same rate. Median house prices grew while median pay fell in 2014. As a result, the affordability ratio grew to 5.6 from 5.3 between 2013 and 2014.
