

## Jarrow Parliamentary Constituency

### Economic Activity



Neighbourhood Statistics shows that there are 61,131 residents in Jarrow aged between 16 and 74. Of these, 68.1% are economically active (this includes unemployed and actively looking for work) which compares to 66.4% in Tyne & Wear and 66.2% for the region as a whole.




The latest economically active figures are an increase on those from the 2001 Census. In 2001, there were 62% of residents aged 16 to 74 classed as economically active. This coincides with an increase in the number of people aged 16 to 74.



Figure 1 below shows economically active are concentrated in Hebburn North (71.7%) and Boldon Colliery (70.9%) wards having highest proportions of economically active 16 to 74 year olds.



Of the economically active total, 58.8% are full-time employees, while 20.8% work part-time employees. A further 7.9% are self-employed and 8.4% are unemployed (and looking for work). The proportion of those in employment has fallen by 1.4% since 2001.

## Benefits and affordability



Nomis data showed that in June, there were 1,685 Universal Credit and Job Seekers Allowance claimants in the constituency, a rise from 1,600 at the same point in 2015. This represents 3.2% of people aged over 16 in the constituency with 25-34 year olds making up 23.6% of claimants.



Using these indicators, it would appear that the Government's aim of a lower welfare country is not being achieved. However, annual survey of hours and earnings data shows that hourly pay for full-time workers grew between 2014 to 2015 from £11.12 to £11.50 – delivering on the higher wage 'settlement'.




Notwithstanding the rise in full-time hourly earnings, Ministry of Justice figures show that total housing possession claims grew (24.2%) but that actual possessions (-50%) fell in the first quarter of 2016 compared to the same period of 2015 in the local authority area.



As Figure 2 shows both social landlord and mortgage possessions fell by 50% over this period, while there was also a fall in mortgage claims (-6.3). There had been no private landlord possessions in recent years and private landlord claims fell by 100% from 7 to none.



However, there were increases in social landlord claims (43.1%) in 2016 Q1 compared with the corresponding quarter of 2015.
