

## Newcastle upon Tyne East Parliamentary Constituency

This is the first bulletin of 2016 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

### Economic Activity



Neighbourhood Statistics shows that there are 77,769 residents in Newcastle upon Tyne East aged between 16 and 74. Of these, 60.2% are economically active (this includes unemployed and actively looking for work) which compares to 66.4% in Tyne & Wear and 66.2% for the region as a whole.



The latest economically active figures are an increase on those from the 2001 Census. In 2001, there were 57.1% of residents aged 16 to 74 classed as economically active. This coincides with an increase in the number of people aged 16 to 74.

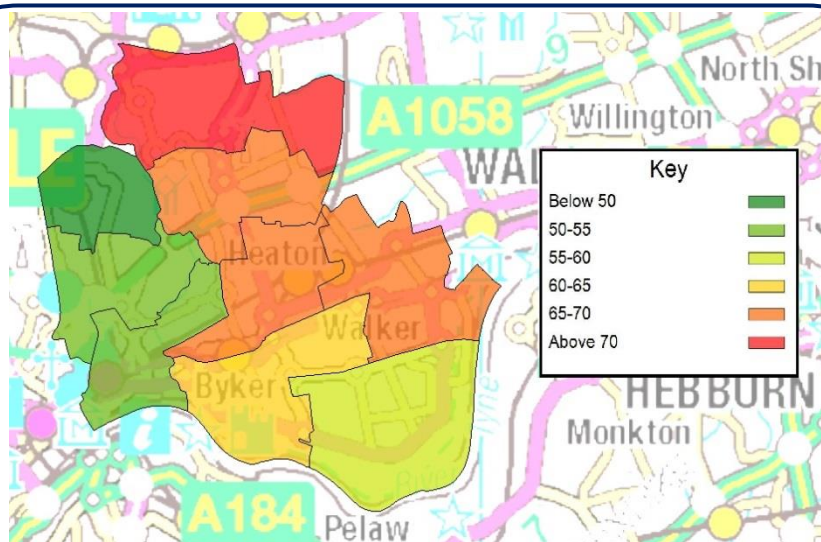


Figure 1: Economically Active by ward

Figure 1 below shows economically active are concentrated in Dene (74.2%) and North Heaton (69%) wards having highest proportions of economically active 16 to 74 year olds.



Of the economically active total, 49.8% are full-time employees, while 16.2% work part-time employees. A further 8.3% are self-employed and 7.8% are unemployed (and looking for work). The proportion of those in employment has fallen by 8.8% since 2001.

## Benefits and affordability



Nomis data showed that in June, there were 1,616 Universal Credit and Job Seekers Allowance claimants in the constituency, a rise from 1,535 at the same point in 2015. This represents 2.2% of people aged over 16 in the constituency with 25-34 year olds making up 28.7% of claimants.



Using these indicators, it would appear that the Government's aim of a lower welfare country is not being achieved. However, annual survey of hours and earnings data shows that hourly pay for full-time workers grew between 2014 to 2015 from £12.78 to £13.01 – delivering on the higher wage 'settlement'.



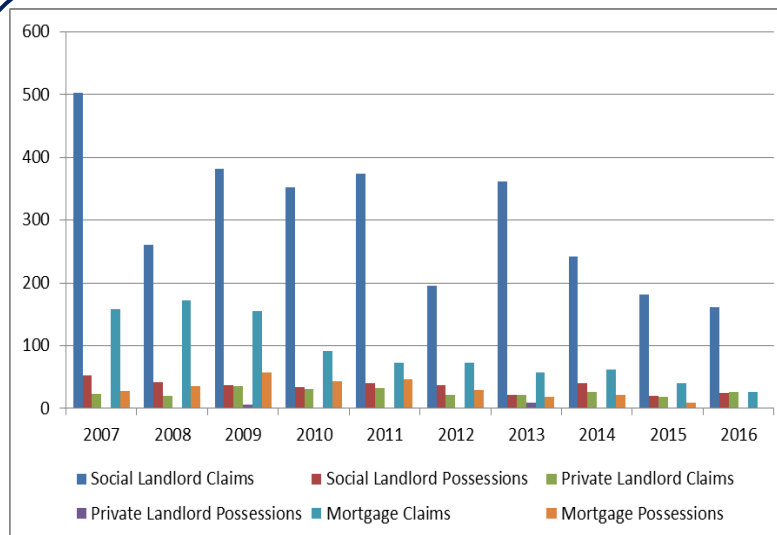
Coinciding with the rise in full-time hourly earnings, Ministry of Justice figures show that total housing possession claims (-11.6%) and actual possessions (-20%) fell in the first quarter of 2016 compared to the same period of 2015 in the local authority area.



As Figure 2 shows social landlord claims fell over this period by 11%. Mortgage claims (-36.6%) and possessions (from 10 to none) were also on a downward trend. There had been no private landlord possessions since 2013 in the city.



However, there were increases in social landlord possessions (20%) and private landlord claims (36.8%) in 2016 Q1 compared with the corresponding quarter of 2015.
