

City of Durham Parliamentary Constituency

This is the second bulletin of 2016 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

We have used the following symbols to indicate your performance against the relevant regional or national statistics.







Private rented sector



Valuation Office Agency data shows that in County Durham LA area there were 5,580 private rents between 1st October 2015 and 30th September 2016. This is out of a total of 9,980 in the North East (21.9%).




The most popular private property size was two-bedroom (2,720) followed by three-bedroom (2,030) and four- bedroom (460). Although VOA data shows that there were 90 private rents of a room, DCLG data shows that there were no homes in multiple occupation (HMO).



Figure 1 below shows the County average private rent for different property sizes and the corresponding Local Housing Allowance (LHA) rate for the Durham Broad Rental Market Area (BRMA). It shows that average rents outstrip the LHA rates and can range from £79.15 for shared accommodation to over £184 for larger properties.



DWP data shows that in August, LHA claimants in the constituency lived in two-bedroom properties (410), followed by properties with one bedroom (391).



LHA and Supported Housing



As Figure 2 below shows, LHA rates for the Durham Broad Rental Market Area (BRMA) ranges from £63.50 for shared accommodation to £138.08 for four bedroom accommodation.



LHA awarded to single people aged below 35 will be restricted to the shared accommodation rate. This is to encourage single people younger than 35 years old to share accommodation which will in turn lead to empty properties elsewhere. Using the average supported rent as a benchmark, this leaves this cohort £16.18 short on their rent.




Furthermore, the Statistical Data Return (SDR) shows that there are 5,803 housing association-owned supported units in County Durham owned by large housing associations with an average net weekly rent being £79.68. This is well above the weekly LHA rate for shared accommodation of £63.50. Therefore, where private rents are cheaper, LHA may not cover supported accommodation costs but will in more expensive areas.



This is causing concern for housing providers with reports that new supported schemes are being put on hold until there is more certainty over how local authorities will administer the fund to top up the cost of supported housing from Government.



Large housing associations own 44,381 units in County Durham. Introducing a regulatory fee of £5 per property to large associations would equate to a cost of £221,905. Furthermore, using average rents and a 52 week rent year, these associations also face a £1.8m fall in rental income in the first year of the 1% rent reduction for stock in County Durham alone.
