

Manchester Central Parliamentary Constituency

This is the first bulletin of 2016 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

Economic Activity



Neighbourhood Statistics shows that there are 107,297 residents in Manchester Central aged between 16 and 74. Of these, 60.5% are economically active (this includes unemployed and actively looking for work) which compares to 67.8% in Greater Manchester and 67.8% for the region as a whole.



The latest economically active figures are an increase on those from the 2001 Census. In 2001, there were 50.9% of residents aged 16 to 74 classed as economically active. This coincides with an increase in the number of people aged 16 to 74.

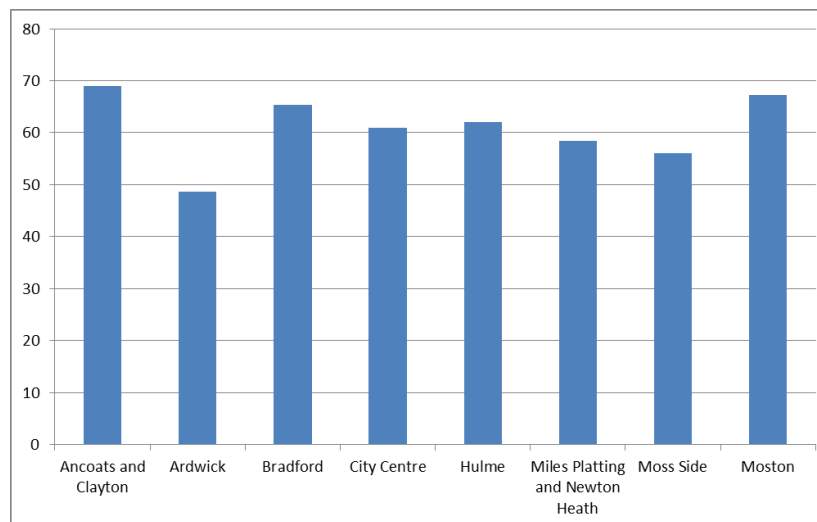


Figure 1: Economically Active by ward

Figure 1 below shows economically active are concentrated in Ancoats and Clayton (69%) and Moston (67.2%) wards having highest proportions of economically active 16 to 74 year olds.



Of the economically active total, 52.4% are full-time employees, while 14.9% work part-time employees. A further 7.8% are self-employed and 9.3% are unemployed (and looking for work). The proportion of those in employment has fallen by 2.1% since 2001.

Benefits and affordability



Nomis data showed that in June, there were 3,110 Universal Credit and Job Seekers Allowance claimants in the constituency, a rise from 2,840 at the same point in 2015. This represents 2.9% of people aged over 16 in the constituency with 25-34 year olds making up 27.5% of claimants.



Using these indicators, it would appear that the Government's aim of a lower welfare country is not being achieved. Furthermore, annual survey of hours and earnings data shows that hourly pay for full-time workers fell between 2014 to 2015 from £11.59 to £11.52 – failing to deliver the higher wage 'settlement'.



Notwithstanding the fall in full-time hourly earnings, Ministry of Justice figures show that total housing possession claims fell by 19% in the first quarter of 2016 compared to the same period of 2015 in the local authority area but that possessions increased (2.1%) over this period.

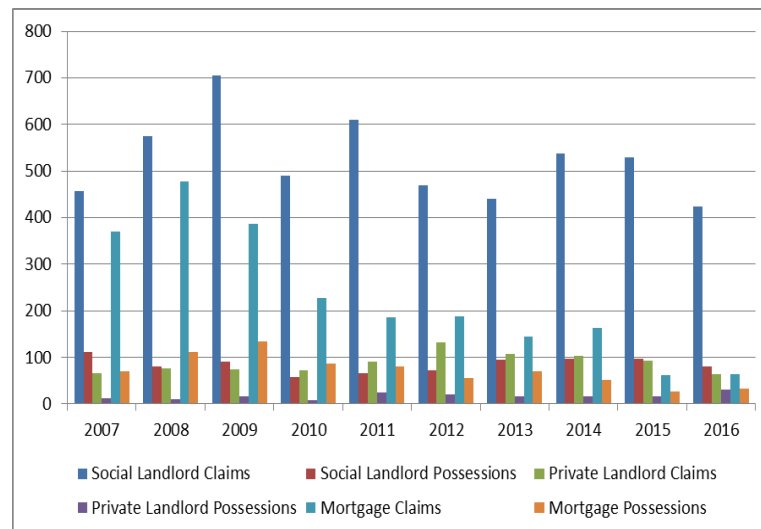


Figure 2: Possession claims and possessions

As Figure 2 shows the social landlord claims (-20%) and possessions (-18.4%) fell from the first quarters of 2015 and 2016. Private landlord claims also fell by 30.4% over this period.



Private landlord possessions (87.5%), mortgage claims (6.6%) and possessions (26.9%) all increased over the same period.
