

## Warrington North Parliamentary Constituency

This is the first bulletin of 2016 produced by Northern Housing Consortium (NHC) providing analysis of housing-related data for the Parliamentary Constituencies in the North of England. The report provides analysis of the impacts of welfare reform and the housing market in the constituency.

### Economic Activity



Neighbourhood Statistics shows that there are 70,982 residents in Warrington North aged between 16 and 74. Of these, 71.1% are economically active (this includes unemployed and actively looking for work) which compares to 70.5% in Cheshire and 67.8% for the region as a whole.



The latest economically active figures are an increase on those from the 2001 Census. In 2001, there were 67.8% of residents aged 16 to 74 classed as economically active. This coincides with an increase in the number of people aged 16 to 74.

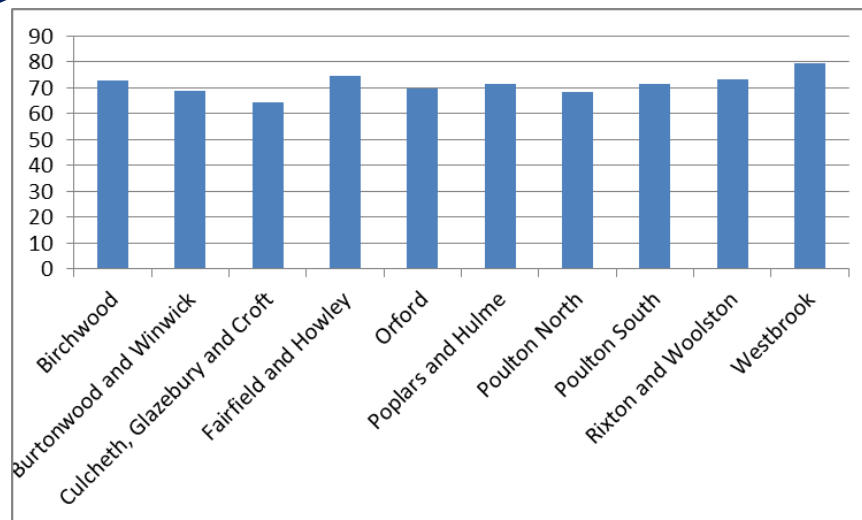


Figure 1: Economically Active by ward

Figure 1 below shows economically active are concentrated in Westbrook (79.2%) and Fairfield and Howley (74.6%) wards having highest proportions of economically active 16 to 74 year olds.



Of the economically active total, 58.5% are full-time employees, while 21% work part-time employees. A further 9.8% are self-employed and 6.3% are unemployed (and looking for work). The proportion of those in employment has fallen by 3.2% since 2001.

## Benefits and affordability



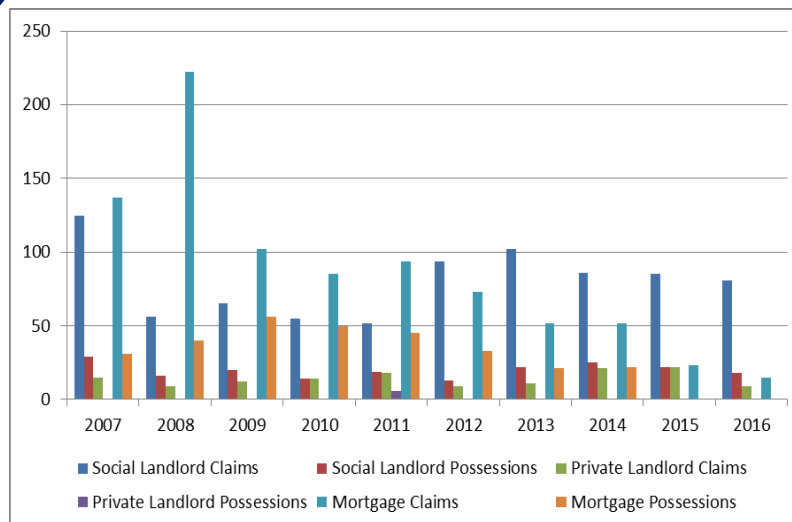
Nomis data showed that in June, there were 1,255 Universal Credit and Job Seekers Allowance claimants in the constituency, a fall from 1,415 at the same point in 2015. This represents 2% of people aged over 16 in the constituency with 35-44 year olds making up 22.6% of claimants.

Using these indicators, it would appear that the Government's aim of a lower welfare country is being achieved. Furthermore, annual survey of hours and earnings data shows that hourly pay for full-time workers grew between 2014 to 2015 from £12.40 to £13.15 – delivering on the higher wage 'settlement'.

Coinciding with the rise in full-time hourly earnings, Ministry of Justice figures show that total housing possession claims (-19.2%) and actual possessions (-18.2%) fell in the first quarter of 2016 compared to the same period of 2015 in the local authority area.

As Figure 2 shows social landlord claims and possessions fell by 4.7% and 18.2% respectively. Similarly, private landlord claims (-59.1%) fell and there have been no private landlord possessions since 2012.

In the mortgage market, there were also falls in claims (-34.8%) while there were no possession in either the first quarter of 2015 or 2016.
